Proposed amendment to the Constitution/By-Laws

Membership Classes

Discussion:

The club By-Laws currently recognize two classes of membership.

Open/Full Member, full voting privileges, full membership fee (currently \$36).
 Family Member, from Open member's household, one vote per family, no additional fees.

In addition, the club has accepted two other classes of membership not formally recognized in the By-Laws.

Junior Member, full voting privileges, ½ membership fee.
 Honorary Member, full voting privileges, no annual membership fee.

All four of the above classes require AMA membership and include full flying privileges.

It has come to my attention that some current members are not renewing their AMA membership and no longer wish to fly. However, they have expressed the desire to continue supporting the club and remain as non-flying members. The AMA, in fact, recognizes such non-flying and non-AMA members as "official" club members and calls them "Associate Members".

Therefore, I propose that we also establish an Associate Member class and in the process amend the By-Laws to formally recognize all five member classes by changing Article IV to read as follows:

Current ARTICLE IV – FAMILY MEMBERSHIP

A membership will include all members of the immediate family living in the same household. A membership card will be issued to the other active and eligible family members upon request. All interested family members are welcome to the meetings, but only one vote per family will be recognized.

Proposed Amendment: Article IV would be replaced with the following table:
