However land purchases would come to a halt and improvement projects would stagnate. If you should vote YES, the Forest Preserve District programs could continue unchanged. Voting will take place on Nov. 4, 2008.

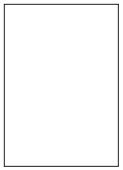
