The meeting was called to order by Pres. Dick Hultz, in the back room of Corky's Pub at 7:15PM.

Meeting Minutes

Treasurer's Report

Steve Yeaton gave the treasurer's report which is posted in the FlyPaper

Field Officer's Report

Bill Lewis reported that the field was in excellent shape and ready for our weekend Fun Fly. He also stated that the Tractor is running great after all the repairs on it.

Safety Officer's Report

Johnnie Russell reported of an incident at the field involving taxiing in the pits that will need to be addressed under new business. Also newer people are flying at the field and some minor rule issues that were brought to their attention.

Events Director

Tony Lawless commented that the "Electric Day" Fun Fly was a great success with a large turnout and all was good for this month's coming up "Giant Scale/Warbirds" day.

Old Business

Dick Hultz reminded everyone that this meeting was the final chance to order shirts and jackets. A question was asked about sizing and Dick said to call the company in Kenosha (Super Sports Footwear @ 262-694-9206) and you could special order sizing, and also change colors. But you will have to discuss this with them individually.

New Business

A request was made to change the eating time at our special events. John Russell recommended 12pm as a start time for food to be served. A motion was made, seconded and passed by vote that food will be served starting @ 12pm on all future events.

An email was sent to the LCFP district complaining about the gate being difficult to open and close. A reply from them stated they would look into it.

Dick reported that some new training cords have been purchased for the club to use with the buddy boxes.

Dick announced the fact that the SkyNights Club will be using the Forest Preserve field as their home field. This might amount to about 10 additional people flying at the field. John Russell brought up a discussion about an incident with one of their members and that we should be courteous to them and if there was any problems (safety) the proper approach would be to simply remind them about the rules and point out where they are posted. Much discussion was had about circumstances that could happen but the overall opinion was that we should be gracious hosts and welcome them to our site.

Dick reported an incident that happened last year, with people flying over the Boy Scout camp, which he just recently found out about. This is strictly prohibited!! "Do not fly outside the posted boundaries."

John Russell brought up an issue of safety (which involved the incident at the field) regarding Taxiing in the pit area. Discussion about how to handle this was had and the resolution (on motion, second and vote) was to send a request to the Forrest Preserve requesting a rule change/addition that states "No Taxing in the pit area". Steve said he would draft a letter and present it to the board for approval and submittal.

Thanks were given to John Russell for handling the 50/50 raffle over the period of time that Sal Grisaffi was gone. Sal will be handling it from here forward and have it at the club picnic.

A report on the AMA requesting information about local clubs was brought up. This is an effort by the AMA to get "history" on local clubs as to when they were founded, by whom, and where. 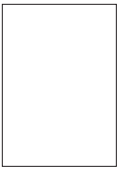
