On a motion, second, and voice note, the meeting was adjourned at 7:31 pm.

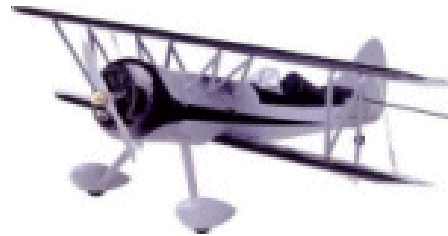

2011 Membership Renewal

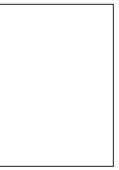
You will need your 2011 AMA card and a current LCRCC membership application/renewal form with only the shaded areas completed unless other information has changed.
