Minutes for the LCRCC Meeting, October 7, 2010

The monthly meeting of the LCRCC was held in the Zion Public Library.

Dick Hultz called the meeting to order at 7:17 with 22 members present.

Secretary report:

The previous months minutes were accepted as printed in the "Flypaper".

Treasurers Report:

The treasurer's report was presented by Steve Yeaton and accepted as read.

Field Officer Report:

Bill Lewis reported that he will have the field ready for Sunday's Fun Fly but that it was in great shape. Due to the late fall conditions less mowing is needed now. Bill, also reported, that there are some major issues with the mower and it appears some costly expenses are up coming.

Safety Report:

John Russell reported all was good and there have been no complaints.

Events Director:

Russ reported about the last event and how good it was and gave details about this month's event (Helicopter day, Oct.3). This will be our last event of the year.

Old Business:

Thanks to Bill Lewis & Chuck Brzezicki for obtaining (and preparing) the food and drinks for the event.

Dick stated that the remaining grass seed will be spread on the new addition before winter (soon).

New Business:

Indoor flying will resume at the Waukegan Field House on Nov. 5th. Your AMA card is required and a pilot fee of \$10 per night. Flying is Friday nights from 9-12pm.

The Rosemont hobby expo is scheduled for Oct 23/24 at the Stevens Convention Center. (Don't miss this show it is always a good one.)

LCRCC officer nominations will be accepted at our November meeting with elections in December. If you wish to nominate someone, or get on the ballot, be at the meeting.

Dick reported on the Board of Directors meeting held on Sept. 29th. This meeting was called to address the issue of the club's financial affairs. This report was sent to all members by Steve (Via Email) so Dick asked for any comments. After some discussion by the members, a motion was made by Gary Allen and seconded by Doug Leffler to accept the \$24 a year increase. The proposal was passed by 2/3s majority vote. Dues will now be \$60 per Year.

Steve Yeaton brought up an issue also discussed at the Club Board meeting. He will be sending out a Questionnaire after the first of the year (by Email) to obtain input from our members as to where they would like to see the club go in the future. 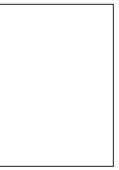
