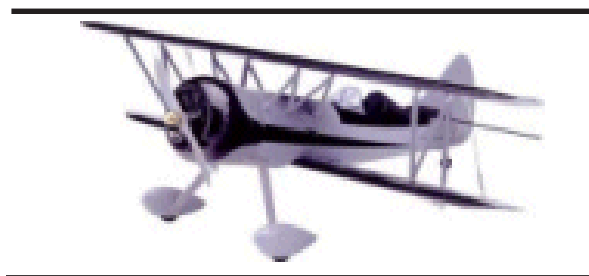

## **Constitution/Bylaws Change**

Many of you may have heard, over the last few weeks, some discussion about the need for a dues increase. Your board of directors met on 9/15 to discuss this issue and now proposes an increase in the annual dues for a regular adult member of 2\$ per month or \$24 per year.

Over the past few years, it has been apparent that our cash reserves (the lowest balance in our combined checking and savings accounts at year end before collecting dues for the next year) have been decreasing. We expect to drop to a low of about \$2,000 before the end of this year. Although this may seem like a lot to many, it is more than \$2,000 below our comfort zone of a few years back.

Our most important asset, as a club, is our mower and tractor. Normal mower and field expenses for this year is likely to be over \$2000. Any extraordinary expense such as mower replacement, which is increasingly likely in the coming years, could easily exceed our current balance. It is the responsibility of the club Board of Directors to insure that we can maintain this asset for the benefit of all the members.

Initial discussion by the board at this meeting concerned an increase of \$1 per month but it was quickly realized that a \$12 per member increase would only stop the slide and barely maintain the current status. Therefore it was unanimously agreed that a \$2 per month increase was necessary to slowly restore our reserves to the previous levels and provide assurance for continued successful maintenance of our beautiful facility.

### **Unanimous request by our Board of Directors**

In keeping with the constitution and bylaws of the Lake County Radio Control Club, this notice shall fulfill the requirement for advanced notice for a vote on a change to the Constitution/Bylaws of the club.

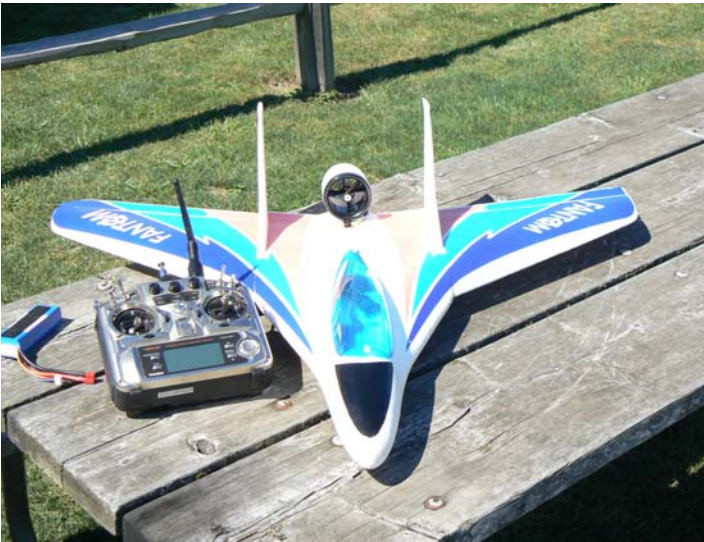
Your Board of Directors hereby requests a dues increase of \$24 per year to \$60 annually (\$30 for junior or associate member). This increase to begin with the 2011 calendar year if approved by 2/3 majority vote on October 7, 2010.

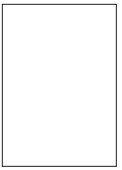
